THIS YEAR THE FOUNDATION GRANTED THE LIBRARY \$311,307 FOR PROGRAMS AND MATERIALS REPRESENTING A 39% INCREASE IN FUNDING TO THE LIBRARY OVER LAST YEAR. SUPPORT WAS GIVEN WITH AN EMPHASIS ON SUMMER READING, ENHANCED EARLY LITERACY AREAS AND INCREASED CHILDREN'S LITERACY PROGRAMS. OF THE \$312,000, \$108,000 CAME FROM THE BOOKS AND MATERIALS ENDOWMENT, AND THE SACRAMENTO ROOM ENDOWMENT DEDICATED TO DIGITIZING THE LIBRARY'S ARCHIVE. IN ADDITION, THE FOUNDATION ALSO SUPPORTED THE MEASURE B CAMPAIGN TO APPROVE AN AUGMENTATION TO THE PARCEL TAX ALLOCATED BY THE CITY OF SACRAMENTO. THESE POSITIVE RESULTS REPRESENT OUR STRATEGIC FOCUS ON ENHANCING CHILDREN'S LITERACY.
